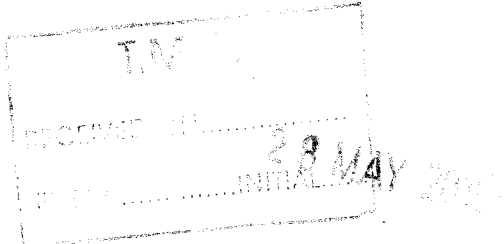
Dear Sir/Ms,
