- iv. Current and Projected requirements viz. Cloth for Local & Export markets.
- v. Projected exports of Towels, Bedwear, Made-ups, Woven & knitted Garments.
- vi. Growth Rates in production and exports for last five-years & projected rates for the next five-years (quantity wise & amount wise).

3. Meetings on the subject are being planned with all the stakeholders in the second week of November 2009 onwards.

TENTH FIVE YEAR PLAN (2010 – 15) INDUSTRIAL DEVELOPMENT

TERMS OF REFERENCE

Prepare an outline of the 10th Plan suggesting implementable actions alongwith financial outlay keeping in view of the following terms of reference:

- i. Suggest measures for accelerating foreign investment in Industrial Sector
- ii. Review disinvestment and privatization of the existing Public Sector Industrial Units and suggest future course of action
- iii. Propose special measures for the development of backward areas.
- iv. Review the existing industrial policy, evaluate its successes and failures and suggest future policies and programmes.
- v. Review manpower, human resource development and training needs
- vi. To develop strategy for local manufacture of turbines and generators for power plants.
- vii. Identify impediments in technology transfer, joint ventures and foreign collaboration.
- viii. Analyze the need for setting up common facility centres, testing labs, etc.
- ix. Propose strategy for establishing linkages between industry and academia on sustainable lines.
- x. Review the availability of raw materials/inputs.
- xi. Identify hurdles in marketing and exports.
- xii. Suggest policy interventions in tariff and financing area.
- xiii. Identify environmental hazards / problems of the industrial sector and propose control measures.
