Check-List for Visa Applicants : Business Visa

General Requirements

- a) Address in Pakistan should match with that of the NADRA card.
- b) Telephone no.'s of applicant and of the host in India are mandatory.
- c) Validity of the passport should be at least 6 months from the date of deposit of the application

Supporting documents for Business Visa

1.	Three completed <i>business</i> visa application forms along with three photographs for single entry. 2 extra sets of application forms along with photographs for each additional entry.
2.	Copy of the NADRA card along with English translation clearly indicating the address. (Applicable w.e.f 05 Nov 2007)
3.	Letters of invitations from Indian companies clearly indicating the city to be visited and the duration of the visit.
4.	Letter from the company in Pakistan giving details of the applicant, his designation and the purpose of the visit.
5.	Copy of Letter of Credit/correspondence with the company in India.
6.	Membership certificate of Chambers of Commerce.
7.	In case of participation in or visiting trade/business exhibitions in India, details of/nature of participation and copy of invitations from the exhibition authorities or Federations/Chambers concerned.

Please note: If any column in the application form is left blank or not filled in complete, the application would be rejected.

Check-List for Visa Applicants : Visitors Visa

General Requirements

- a) Address in Pakistan should match with that of the NADRA card.
- b) Telephone no.'s of applicant and of the host in India are mandatory.
- c) Validity of the passport should be at least 6 months from the date of deposit of the application.
- d) All previous passports should be attached (not necessary if the applicant has traveled on the present passport to India.)
- e) Children should apply on their own separate passports.
- f) Pakistani of dual nationality MUST apply on their PAKISTANI passports.
- g) All supporting documents should be clear and legible.

Supporting documents for Visitors Visa

<i>From Pakistan: (These requirements are applicable w.e.f 05 Nov 2007)</i>	
1.	Copy of the NADRA card along with English translation clearly indicating the address.
2.	Copy of the electricity bill/gas bill/landline telephone bill (Any two).
3.	Any one of the following:
a)	For Employees working in the Government, a letter from either the Head of the Department or copy of the clearance received from the Government of Pakistan/Provincial Government.
b)	For an employee in the private sector, a letter from the organization giving the details of designation, duration of service and address of the applicant.
c)	For self-employed businessman, a copy of their Registration Certificate with the Government along with an English translation (if not in English)
<i>From India:</i>	
1.	Affidavit from relative/host in India indicating willingness to bear responsibility of the visit. Address and telephone number of the host must be clearly indicated.
2.	Documents such as electricity bill, telephone bill, ration card, Election I-card of the relative/host in India identifying clearly the address (any two)

- **If any column in the application form is left blank or not filled in complete, the application would be rejected.**
- **Application form should be typed or clearly written.**
