Subject: **Drawback of Local Taxes & Levies Scheme**

I invite your attention to this Ministry's Notification No.3(1)TID/09-P-I dated 15<sup>th</sup> February, 2010 (copy enclosed) regarding certain amendments in the Drawback of Local Taxes & Levies Order, 2009 dated 1<sup>st</sup> September, 2009. In this regard, it may please be noted that the provisions of the said notification are applicable only to the shipments made after the issuance of the same i.e. after 15.02.2010.

2. I am further directed to intimate that in view of ongoing registration process in this Ministry, a one-time extension of time limit has been granted for filing of Drawback claims. All the exporters bearing Permanent or Provisional (whether valid or expired) Registration Certificates may submit Drawback claims till 31.03.2010 in respect of the shipments made after 01.09.2009. State Bank of Pakistan may admit all such claims if they are otherwise in order; however, no payment will be made to any claimant unless it presents the Permanent Registration Certificate.

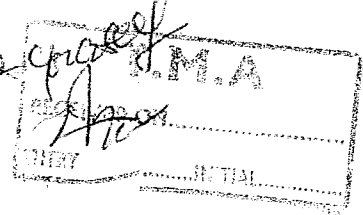

**Notification**

**No.3(1)TID/09-P-I** In supersession of this Ministry's Notification of even number dated 20<sup>th</sup> January, 2010 and in partial modification of Ministry of Textile Industry Order titled "Drawback of Local Taxes and Levies Order, 2009" issued vide Notification No.3(1)TID/09-P-I dated 1<sup>st</sup> September, 2009, the following amendments shall be made:-

2. Para 2(3) shall be substituted with the following and will read as:-

"The unit availing the drawback shall be a registered sole proprietor, partnership or a company and shall be a member of any of the following Associations registered with the Directorate of Trade Organizations, Ministry of Commerce, for products indicated against each Association, namely;

3.	All Pakistan Textile Mills Association (APTMA)	Home Textiles, Fabrics, yarn

5.	Pakistan Denim Manufacturers & Exporters Association (PDM&EA)	Denim Fabrics


3. In para 2, a new sub clause (4) shall be added, which will read as follows:-

(4) "If a product is being handled by more than one Association, a textile unit will have the option to register itself with any Association from within the list prescribed above. Option once exercised will be final and the unit so registered for verification of export of that particular product will not switch the Association unless, on the basis of a justifiable written request, is allowed to do so by the Ministry of Textile Industry".

4. In Annexure-I, in the list of Home Textiles products, HS Code 63071030 shall be added which will qualify for Drawback of 2%.

5. In Annexure-III, para-d shall be substituted with the following and will read as:

"Copy of B/L / House Airway Bill along with Airway Bill (FCR along with Master Bill of Lading). Master Bill of Lading will be mandatory in cases of Documents against Payment (DPs) while it will not be mandatory in cases of Letters of Credit (LCs)".
