REF : - OGRA SRO (1)/2019 DATED 29 JUNE 2019

Dear Members,

We have to inform you that consequent to withdrawal of Zero Rating on Gas Bills, SSGC has to adopt following mechanism for charging of reduced gas tariff in accordance with **OGRA Notification SRO Notification SRO(I)/2019 Dated 29th June 2019**.

Therefore you are requested to provide requisite information to SSGC before 25th July 2019 in order to avail provision of reduced gas tariff of serial (VI) of SRO (I) 2019.

1. Application on Company's Letter Head confirming that you fall in the category of "Registered Manufactures or Exporter of Textile (Including Jute), Carpet, Sport and Surgical goods" any you are entitled for Gas Tariff under serial VI of SRO.
2. **Under-taking on Rs.100/- Stamp Paper** ([PLEASE CLICK SPECIMEN](#)) that at any time the nature of business is changed the same is reported to SSGC for withdrawing of gas tariff of serial VI of SRO failing which SSGC shall be entitled to recover short-billed charges, if any.
3. Letter of Recommendation from Association.
4. F.B.R Registration status to reflect that Customer is registered for Sales Tax as Manufacturers of Exporter in the category of Five Zero Rated Sectors at FBR (STRN / NTN)

You are advised to strictly follow the above instructions of SSGC otherwise you will be not be able to avail **Reduced Tariff and Normal Rate Tariff** i.e **Rs. 1021 Per MMBTU will be applied.**
