July-March: FBR surpasses Rs6,707bn collection target

ISLAMABAD: The Federal Board of Revenue (FBR) has surpassed the assigned revenue collection target of Rs 6,707 billion during July-March (2023-24) and collected Rs. 6,710 billion during this period.

Petrol price hiked, diesel's slashed ahead of Eid

ISLAMABAD: The federal government ordered a significant raise in petrol price by up to Rs 9.66 per litre, effective from April 1, 2024, further adding financial burden on general public. The recent surge in petrol prices is attributed to an increase in premium from \$12.15 per barrel to \$13.507 per barrel, marking a \$1.45 per barrel increment.

WASHINGTON: The US economy grew faster than previously estimated in the fourth quarter, boosted by strong consumer spending and business investment in non-residential structures like factories and healthcare facilities.

Govt increases petrol price by Rs10 per litre

ISLAMABAD: Days before Eidul Fitr, the government on Sunday increased the price of petrol by Rs9.66 per litre and reduced that of high-speed diesel (HSD) rate by Rs3.32 per litre for the next fortnight ending April 15.
