<u>Jul-Mar trade deficit shrinks 24.94pc to \$17.03bn YoY</u>

ISLAMABAD: Pakistan's trade deficit narrowed down by 24.94 percent in the first nine months (July-March) of the current fiscal year 2023-24 as it stood at \$17.030 billion compared to \$22.688 billion during the same period of last fiscal year, says the Pakistan Bureau of Statistics (PBS).

Top taxpayers: Pakistan Honour Card Scheme to be announced

The FBR will announce the "Pakistan Honour Card Scheme" for the top taxpayers including exporters to grant privileges and facilities, especially at airports. The "Pakistan Honour Cards" would be issued to 65 top exporters and compliant taxpayers including companies, Associations of Persons (AOPs), and individual taxpayers, who received awards from Prime Minister Shehbaz Sharif.

Prior to March 21st: FBR issues all refund claims of exporters

ISLAMABAD: The Federal Board of Revenue (FBR) has issued all sales tax refund claims of exporters which were created prior to March 21, 2024. This is the second phase of speedy payment of refunds after issuance of refunds of Rs 65 billion to the exporters on March 3, 2024.

Businessmen reject 'Tajir Dost' scheme

KARACHI: Businessmen on Monday rejected the government's 'trader-friendly tax scheme' labelling it as detrimental to the economy. "The government's economic policies are incomprehensible," Mehmood Hamid, President of the All Pakistan Organization of Small Traders and Cottage Industries Karachi said.

<u>Japanese firms reluctant to expand business</u>

KARACHI: Japanese companies operating in Pakistan are least interested in further investment to expand their businesses, while the country ranked lowest in the region. "Unstable security, high inflation and an unstable exchange rate are major business concerns for Japanese companies operating in Pakistan," said an official Japanese government survey on Monday.

The details of Pakistan International Airlines' outstanding debt to the government as well as banks have surfaced, revealing that its total dues amounted to Rs429.267 billion by September 30, 2023.

ISLAMABAD: President Asif Ali Zardari has called for an early finalization of the Transit Trade Agreement (TTA) with Turkmenistan to further boost bilateral cooperation between the brotherly countries, and said that the agreement, once signed, would help expand trade, promote regional connectivity as well as enhance economic activities in the region.

Pak-China trade resumes as Khunjerab border opened after 4 months

GILGIT: As many as 15 trucks carrying goods from China entered Pakistan on Monday marking the resumption of trade activities between the two countries through Khunjerab Pass which remained close for four months.

PSO receivables mount to Rs804.5bn by March closure

Pakistan State Oil (PSO), the state-controlled oil marketing firm, is wrestling with an alarming financial crunch as its receivables have ballooned to over Rs800 billion by March end, exacerbated by delayed payments from both public and private sectors, industry officials said on Monday.
