G2G framework : Plan approved to hand over Islamabad Airport operations to UAE

ISLAMABAD: In a decisive move aimed at boosting the country's economic and strategic ties with the Gulf, the Cabinet Committee on Inter-Governmental Commercial Transactions (CCoIGCT) approved on Thursday a plan to hand over operations of Islamabad International Airport to the United Arab Emirates under a government-to-government (G2G) framework.

Consolidated financial statements: SBP posts record profit of Rs2.5trn for FY25

KARACHI: The State Bank of Pakistan (SBP) reported a record net profit of Rs2.5 trillion for the fiscal year 2024-25 and after statutory appropriations, Rs. 2.428 trillion was handed over to the Federal Government, the central bank announced on Wednesday.

Ogra-determined rates: CCoE set to allow SNGPL, SSGCL to provide RLNG connections

ISLAMABAD: The Cabinet Committee on Energy (CCoE) is set to allow Sui Northern Gas Pipelines Limited (SNGPL) and Sui Southern Gas Company Limited (SSGCL) to provide Re-gasified Liquefied Natural Gas (RLNG) connections to pending applicants at Oil and Gas Regulatory Authority (OGRA)-determined rates,

KARACHI: The Pakistani rupee registered marginal improvement, appreciating 0.01 percent against the US dollar in the inter-bank market on Thursday.

New German CG pledges priority to business visas: FPCCI

KARACHI: Atif Ikram Sheikh, President FPCCI, has said the newly-appointed Consul General of Germany in Karachi, Thomas Eberhard Schultze, has apprised the business, industry and trade community from the apex platform of the FPCCI that the business visas will be given priority in the visa issuance to Pakistani citizens as economic relations top the agenda.

HBL joins hands with Mastercard to launch business debit card for SMEs

KARACHI: HBL has joined hands with Mastercard in launching its business debit card designed exclusively for SMEs - sole proprietors and entrepreneurs. Two card variants have been launched, Classic and World Business Debit Card.

Industrial sector: PAC steps up pressure on Ogra, SNGPL for Rs51.3bn recovery

ISLAMABAD: The long-running dispute over Re-Gasified Liquefied Natural Gas (RLNG) pricing took a sharp turn on Thursday as the Public Accounts Committee (PAC) intensified pressure on the Oil and Gas Regulatory Authority (OGRA) and Sui Northern Gas Pipelines Ltd (SNGPL) to recover Rs51.3 billion from the industrial sector.

Toll manufacturing: SHC disposes of pleas on ST collection after FBR-SRB statement

ISLAMABAD: Sindh High Court has disposed of all petitions and reference applications on collection of sales tax on toll manufacturing after submission of a joint statement by the Federal Board of Revenue (FBR) and Sindh Revenue Board (SRB).

Cotton market: Falling trend continues amid hectic activity

LAHORE: The Spot Rate Committee of the Karachi Cotton Association (KCA) on Thursday reduced the spot rate by Rs 100 per maund and closed it at Rs 16,000 per maund. Cotton Analyst Naseem Usman told Business Recorder that the local cotton market remained easy and the trading volume remained satisfactory.

Rs23bn fuel refund on cards

ISLAMABAD: The National Electric Power Regulatory Authority (Nepra) on Thursday took serious notice of 11 rain-related fatalities in July, mostly due to electrocution, as it held a public hearing on a proposed Rs1.69 per unit refund to consumers on account of cheaper fuel costs than charged in the same month.

Glitches in tax portal

ISLAMABAD: The Karachi Tax Bar Association (KTBA) has warned that persistent technical and legal flaws in the Federal Board of Revenue's (FBR) Iris portal are obstructing the filing of income tax returns for Tax Year 2025 and could undermine compliance.

SBP earns Rs2.5tr profit

KARACHI: The State Bank of Pakistan (SBP) on Thursday reported a net profit of Rs2.5 trillion for FY25, of which Rs2.428tr has been transferred to the federal government as surplus. The record earnings were mainly driven by the policy rate, which remained as high as 22pc during the year.

New US consul general takes charge

KARACHI: Charles Goodman has assumed the role of consul general at the US Consulate General in Karachi. According to an announcement on Thursday, his appointment reflects the ongoing US commitment to fostering a strong partnership with Pakistan.

Pakistan moves to hand over Islamabad Airport operations to UAE in G2G deal

ISLAMABAD: Pakistan has cleared the way for the United Arab Emirates (UAE) to take over operations at the Islamabad International Airport, marking the first step in outsourcing the management of the country's largest airports under government-to-government (G2G) agreements.

ADB pledges \$410m for Reko Dig project

ISLAMABAD: Out of the total \$6 billion funding committed by all international lenders for Reko Diq, the Asian Development Bank (ADB) has committed to provide financing of \$410 million. Visiting ADB President Masato Kanda met Prime Minister Shehbaz Sharif here on Thursday.

SBP earnings decline as interest rates fall

KARACHI: The State Bank of Pakistan (SBP) reported a net profit of Rs2.5 trillion for the fiscal year that ended on June 30, down from Rs3.4 trillion a year earlier, due to lower earnings from government debt amid declining interest rates.

SME financing roundtable held

KARACHI: The Karachi School of Business and Leadership (KSBL) and JS Bank jointly hosted a strategic roundtable to address the opportunities and challenges shaping Pakistan's SME financing landscape, a statement said on Thursday.

SBP forex reserves rise by \$18m to \$14.27bn

KARACHI: Pakistan's foreign exchange reserves held by the central bank rose for a third straight week and stood at \$14.274 billion as of August 22, the State Bank of Pakistan (SBP) said on Thursday.

Pakistan welcomes Japan Bank's entry into Reko Dig lender group

ISLAMABAD: The Japan Bank for International Cooperation (JBIC) has joined the lender group for Pakistan's multibillion-dollar Reko Diq copper and gold project, a step the government hailed on Thursday as a pivotal boost for foreign investment in the country's mining and energy sectors.

FPCCI challenges retrospective RLNG debits

KARACHI/LAHORE: The Federation of Pakistan Chambers of Commerce & Industry (FPCCI) has objected to retrospective "actualisation" debits raised by Sui Northern Gas Pipelines Limited (SNGPL) on RLNG supplies to the industrial sector and urged the Oil and Gas Regulatory Authority (Ogra) to provide relief, calling the move unjustified.
