Fuel hikes outweigh cuts under daily pricing

ISLAMABAD: Despite a string of cuts since the government introduced daily pricing, petrol has ended up Rs25.87 per litre costlier, while diesel has also recorded a net increase of Rs17.09, an analysis of price changes shows.

RLNG crunch dims country after dark
