## **Govt praised for abolishing EDS**

KARACHI: The business community has welcomed the decision of government to abolish the Export Development Surcharge imposed on export-oriented industries, terming it a step in the right direction towards support to export growth receipts, while urging the government to continue the facilitation to exporters for enhancing the competitiveness of Pakistani products in the global markets.

## Former FPCCI president says inflation surge threatens recovery

LAHORE: The FPCCI Businessmen Panel (BMP), expressing concern over the fresh uptick in inflation, said that the economy is again showing signs of strain, as consumer prices rose by 6.2 percent in October 2025 — the highest level in a year — mainly due to food supply disruptions, floods, and trade bottlenecks on the western borders.

## Petrol price slashed by Rs2, HSD's by Rs4.79

ISLAMABAD: The federal government has announced a reduction in the prices of key petroleum products, effective for the first half of December (December 1-15). High-Speed Diesel saw a significant cut, decreasing by Rs 4.79 per litre. Meanwhile, the price of petrol was reduced by Rs 2 per litre.

## Formal sectors: Aurangzeb hints at reducing taxes

ISLAMABAD: Finance Minister Mohammad Aurangzeb cautioned that the government will keep a close eye on balance of payment and current account to ensure sustainability in growth, but ready to reduce taxes on formal sectors with the help of Tax Policy Office fully engaged to facilitate formal sector where ever fiscal space is available.

## FTO recommendation: FBR delays implementation

ISLAMABAD: The Federal Board of Revenue (FBR) has delayed implementation of a key recommendation of the Federal Tax Ombudsman (FTO), which was also duly upheld and confirmed by the President Asif Ali Zardari to constitute a team of sales tax/ IT experts to implement an IT-based system for eliminating the menace of fake/ flying sales tax invoices.

Pakistan's textile industry has long served as a backbone of the national economy. It contributes heavily to the country's GDP, drives export earnings and provides employment to millions of workers. Despite its historic strength, the sector is now under serious strain.

## **Extending upward momentum**
