Arif Habib Group-led consortium makes highest bid for 75pc stake: Finally, PIA goes private for Rs135bn

A consortium led by the Arif Habib Group on Tuesday emerged as the winning bidder for the acquisition of a 75 percent stake in PIA, submitting a top bid of Rs 135 billion —35 percent above the government's reference price—and committing to invest an additional Rs 80 billion over the next five years.

Rs135bn bid finally takes PIA off govt hands
