### Concerns persist over hybrid cotton's viability

LAHORE: Pakistan's cotton sector is grappling with a severe crisis as production has plummeted from a record 15 million bales to just 5.5 million, raising alarms across the textile value chain. The shortfall has significantly strained foreign exchange reserves as the country increasingly relies on imported cotton to meet the demands of its textile industry.

KARACHI: Foreign exchange companies contributed around \$450 million to remittance inflows during June, taking their total contribution to approximately \$5 billion in FY25, according to the Exchange Companies Association of Pakistan (ECAP).

#### Cash-strapped govt collects Rs490bn through taxes in electricity bills in FY25

ISLAMABAD: The government has collected Rs490 billion through electricity bills in the shape of Withholding Tax (WHT) and General Sales Tax (GST) from consumers in the fiscal year 2024-25, compared to Rs600 billion collected in the same period of the preceding financial year.

#### Govt debt hits Rs76tr as of May, up 12.3% YoY

KARACHI: Pakistan's government debt climbed to Rs76.05 trillion (~\$270 billion) by May 2025, up 12.3 per cent year-on-year (YoY). According to data released by the State Bank of Pakistan (SBP) on Friday, the debt rose by Rs8.31 trillion in the 12 months ending May 2025. Notably, Rs1.1 trillion was added in May alone.

#### Stocks surge to record high; momentum likely to continue

KARACHI: With the KSE-100 index breaking through the psychological barrier of 130,000 points for the first time in history and ending the week at 131,949 points, up 6.0 per cent week-overweek (WoW), the Pakistan Stock Exchange (PSX) got off to a bullish start to FY26.
