#### FBR tells PM: Tax-to-GDP ratio jumps 1.5pc to 10.6pc

ISLAMABAD: The Federal Board of Revenue (FBR) on Wednesday said the country's tax-to-GDP ratio rose by 1.5 percentage points in FY2025, reaching 10.6 percent compared to FY2024 – a notable advance towards the government's goal of 13 percent under its three-year reform agreement with the International Monetary Fund (IMF).

#### Trump strikes tariff deal with Japan

WASHINGTON/TOKYO: US President Donald Trump struck a trade deal with Japan that lowers tariffs on auto imports and spares Tokyo from punishing new levies on other goods in exchange for a \$550 billion package of US-bound investment and loans.

#### Pakistan, Afghanistan sign long-awaited PTA

ISLAMABAD: Pakistan and Afghanistan on Wednesday signed a long-awaited Preferential Trade Agreement (PTA) following two days of intensive negotiations.

#### Monetary policy poll: 50-100bps cut expected

KARACHI: As per the market expectations, the State Bank of Pakistan (SBP) is likely to cut the key policy rate in its Monetary Policy Committee (MPC) meeting to be held on July 30, 2025. In a poll conducted by Topline Securities, 56 percent of the market participants expect a 50-100bps cut in upcoming monetary policy meeting compared to 44 percent in last poll.

## Has Rs1.71/unit electricity relief vanished?

It was widely expected that the government would continue the Rs1.71 per unit electricity subsidy component—backed by the IMF staff-level agreement, which explicitly cited plans to fund the relief via additional Petroleum Levy collections.

## Discos' June FCA: FPCCI flags objections and regulatory queries

ISLAMABAD: The FPCCI has raised formal objections and regulatory queries on FCA of Discos for June 2025. In a letter to Registrar, Nepra, FPPCI said that while the proposed negative adjustment of Rs. 0.6541/kWh may appear consumer-friendly but it grossly under-represents the hidden inefficiencies, persistent opacity, and regulatory shortcomings plaguing the power sector.

## PVMA threatens to shutdown ghee production if FBR powers not withdrawn

KARACHI: The Pakistan Vanaspati Manufacturers Association (PVMA) has warned of an indefinite shutdown of ghee production across the country if the government fails to withdraw certain powers granted to the Federal Board of Revenue (FBR) within 48 hours.

#### M-Tags made mandatory for vehicles entering capital

ISLAMABAD: In a major move towards transforming Islamabad into a smart city, the Capital Development Authority (CDA) has decided to make M-Tags mandatory for all vehicles entering the city, alongside introducing digital parking and a cashless transaction system.

#### **PKR: marginal improvement**

KARACHI: The Pakistani rupee registered marginal improvement against the US dollar, appreciating 0.07% in the inter-bank market on Wednesday. At close, the currency settled at 284.76, a gain of Re0.21. On Tuesday, the currency settled at 284.97.

#### Gold prices soar in local market

Gold prices took a big stride on Wednesday in the local market, tracking an international market uptrend, surpassing \$3,400 per ounce, traders said. World market posted a big gain, soaring by \$37, to settle at \$3,424 per ounce that also fuelled the local gold value, APSGJA said.

#### Gold prices fall on US-Japan trade deal

Gold prices fell on Wednesday after a US-Japan trade deal eased market uncertainty, while strong industrial demand and a supply shortage drove silver to its highest level since September 2011.

#### Mills' active buying help prices to keep present levels

The local cotton market on Wednesday remained steady and the trading volume remained satisfactory. Cotton Analyst told Business Recorder that the arrival of Phutti was affected due to rains. He also told that the rate of new cotton in Sindh is in between Rs 16,100 to Rs 16,300 per maund and the rate of cotton in Punjab is in between Rs 16,300 to Rs 16,600 per maund.

## Rate cut hopes rise as T-bill yields fall

KARACHI: The State Bank of Pakistan (SBP) on Wednesday slashed treasury bill (T-bill) yields by up to 39 basis points, signalling possible room for a policy rate cut in the upcoming monetary policy meeting scheduled for July 30.

#### **Ghee makers threaten strike**

KARACHI: The Pakistan Vanaspati Manufacturers Association (PVMA) warned on Wednesday of an indefinite shutdown of ghee and cooking oil production nationwide if the Federal Board of Revenue (FBR) fails to withdraw its controversial tax enforcement powers within 48 hours.

## Pakistan, Afghanistan sign trade agreement

ISLAMABAD: Pakistan and Afghanistan on Wednesday signed an Early Harvest Programme (EHP) to reduce tariffs on eight agricultural items for one year, laying the foundation for a broader preferential trade agreement (PTA) between the two countries.

#### Pakistan, BD agree on visa-free entry for officials

ISLAMABAD: Paki-stan and Bangladesh on Wedn-esday agreed to grant visa-free entry to holders of diplomatic and official passports from the other side.

#### Pakistani passport still ranked among 'weakest' despite improvement

KARACHI: While the passports of other Asian countries have emerged as the most powerful in the world, Pakistan's travel document continues to be ranked among the 'weakest' in the world, with visa-free access available to only 32 destinations.

## ADB revises Pakistan's FY25 growth to 2.7pc
