### Govt urged to revisit power package

ISLAMABAD: The Federation of Pakistan Chambers of Commerce and Industry (FPCCI), the Korangi Association of Trade and Industry (Kati) and the Bin Qasim Association of Trade and Industry (BQATI) have urged the government to review the Prime Minister's proposed power incremental package and reduce the incremental tariff rate from Rs 22.98/kWh to Rs 16/kWh.

KARACHI: Jameel Ahmad, Governor, SBP Monday said Pakistan has achieved significant macroeconomic stability by pursuing coordinated and prudent monetary and fiscal policies, which have led to a sharp reduction in inflation, and a rebuilding of external and fiscal buffers.

KARACHI: President of the KATI Ikram Rajput has termed the increase in remittances sent by overseas Pakistanis during October as a highly encouraging development for economy. According to the latest figures, remittances grew by 11.9 percent in October, reaching USD3.4 billion.

### PKR: marginal gain

KARACHI: The Pakistani rupee registered marginal gain against the US dollar in the inter-bank market on Monday. At close, the currency settled at 280.81, a gain of Re0.01 against the greenback.

During the previous week, the Pakistani rupee posted marginal gain as it appreciated by Re0.09 or 0.03% against the US dollar in the inter-bank market.

### Spot rate gains Rs200 per maund

LAHORE: The Spot Rate Committee of the KCA on Monday increased the spot rate by Rs 200 per maund and closed it at Rs 15,200 per maund. Cotton Analyst Naseem Usman told Business Recorder that the rate of new cotton in Sindh is in between Rs 14,750 to Rs 15,400 per maund and the rate of cotton in Punjab is in between Rs 14,800 to Rs 15,500 per maund.
